Dr. Hamilton is a member of the American Dental Association, the Ohio Dental Association, the Cincinnati Dental Society, the American Association of Oral and Maxillofacial Surgeons, the Ohio Society of Oral and Maxillofacial Surgeons, the Cincinnati Society of Oral and Maxillofacial Surgeons and the International College of Dentists.

Dr. Hamilton completed his undergraduate studies at Centre College in Kentucky and received his dental degree from Case Western Reserve University in Cleveland. In addition to his dental degree and oral surgery credentials, Dr. Hamilton earned a master's in business administration from the Xavier University Williams College of Business.

There are currently 13 members serving on DCPG's Board of Directors. Seven board members are dentists and the remaining six are representatives from the private-sector.
